Microsoft's (MS **(1)**) third-quarter report **(2)** indicates that its record profits are due to MS Office **(3)**, xBox **(4)**, and Kinect **(5)**. The operating system (OS **(6)**) and server market was also up, yet accounted for a smaller percent of overall profits. This does not mean that Windows 7 **(7)** market is soft. It means that the OS is no longer the backbone of MS. We may soon see MS Office offered in a Linux **(8)** version. If you are considering the purchase of a satellite navigation system **(1)** for your car, here is some news to consider. TomTom **(2)**, a service provider and manufacturer of satellite navigation systems, whose business is world wide, but is Europe's largest provider, sold customer information in the form of routes traveled and speed of travel to the Dutch Police **(3)**. The Dutch Police uses this information to set up "speed traps" **(4, 5)**. TomTom's profits have been shrinking due to smart phone **(6)** sales. Some smart phones have a navigation system built in, thus discouraging the sales of automobile based navigation systems. TomTom sold anonymous customer data in an effort to boost profits. As far as we know, they have only sold data to the Dutch. How long will it be before they sell to other governmental units within the U. S.? How long will it be before competitors like Garmin **(7)** and Onstar **(8)** sell data?

One of our members had a problem with Windows 7 updates. Windows Update **(1)** generally works automatically without any user intervention. Like many Windows updates, these updates

(four of them) required Windows to be rebooted. After the reboot, our member would get a message that the update cannot be configured and the process was cancelled. The update scheduler would check for updates on a regular basis, download them, install them, and demand that the machine be rebooted. After the reboot the same messages would appear, then it would start all over again. When a computer does something over and over again with the same non-productive result, the action is called a loop. With the most recent Win 7 updates, I had had the same problem. The way I solved the problem was to not let the automatic update happen. I went through the update manually. I went to Windows Update by clicking the start button (orb) and typing 'update' (without the tick marks). At the top of the list (or close to the top) should be Windows Update. Click on it. The Windows Update window appears. Click the button in the upper right side of the window that reads Install updates. Watch the install. If the window disappears, a message will appear on the start tray. Click that message to bring up the installation window. When the installation is complete, a button will appear to restart the computer. Click that button. The shutdown and restart are relatively lengthy for those updates. Once the computer has restarted, repeat this process to see if there are any updates to install. There should not be any.

I came across a new term recently, 'Windows rot' **(1)**. It is the description of the aging of a Windows computer. As the computer is used, programs are added or deleted the computer becomes progressively slower. There is some debate about whether this is an actual problem or just a perception **(2, 3)**. There are many sites that offer tips to lessen the effect **(4, 5, 6)**.

iolo Technologies **(7)** claims that startup times increase by about 330 per percent over a two year span. A business named n# has a method of increasing a low RAM memory Win XP machine speed **(8)** that has to do with resizing the swap file. liutilities **(9)**, maker of Uniblue, web site has many helpful hints on speeding up a Windows machine. I do not recommend Uniblue, which has been renamed PowerSuite 2011. It is a \$60 utility that tries to take over your machine. It does the same things that free utilities do. It also has a free download that identifies problems then directs you to purchase the program to fix what it found. That method of marketing is similar to the trojan malware that pops up telling you your machine is infected and to rid yourself of the infections you can, but the program to do it, is their program. I reported on this malware in Lamp Post 113 in February of 2010 **(10)**.

Web storage or cloud storage **(1)** of documents is becoming more popular. It allows users to store data files on the Internet. Some companies feature file synchronization. All companies that I have checked have a free service and a paid service. Some services are platform independent (PCs, Macs, Linux, iPhone, Android all work). MS has SkyDrive **(2)** which began in 2007. I have mentioned Google Docs **(3)** in previous Lamp articles. It was started after Google acquired Writely **(4)** in 2006. Don't be put off by the demo page of Google Docs. It just looks complicated, but it is actually quite simple. Dropbox **(5)** has been around since 2007. Box.net **(6)** was founded in 2005. Memopal **(7)** was started in 2008. ADrive **(8)** began life in 2007. All these services will give you more storage space for a fee. All have encryption to prevent cracker attacks. Policies regarding privacy and government snooping are obfuscated in legalese (on purpose?). Other services include SugarSync **(9)**, ZumoDrive **(10)**, TeamDrive **(11)**, Ubuntu One **(12)**, OpenDrive **(13)**, Syncplicity **(14)**, SpiderOak **(15)**, and IDrive **(16)**. There are some among our membership that were very concerned by the appointment of Sonia Sotomayor **(1)** and Elena Kagan **(2)** to the Supreme Court of the United States **(3)**. Both Kagan and Sotomayor were appointed by President Obama **(4)**. The expectation was that they would make liberal rulings. In a recent ruling **(5)** regarding the 4th amendment **(6)**, Kagan and Sotomayor ruled with the majority (8-1) that, essentially, warrants are no longer needed to break into a home and search it. only justice that read the amendment and understood that for the last 219 years a warrant was necessary before a search can take place. That is a truly liberal position. I guess Kagan and Sotomayor are actually conservative. In a related ruling by the Indiana Supreme Court **(9)**, the court said that "public policy" has determined that warrants are no longer needed **(10)**. I'm guessing that Bill of Rights day will never be the same **(11)**.
